I have not been involved at any time in any act of moral turpitude; and have never been convicted of any crime and do not have any criminal charges pending against me; nor have I ever done any act or engaged in any activity which is or could be characterized as dishonest, immoral, immodest, indecent or in bad taste. I hereby warrant that I will continuously maintain and keep my morality at this level, especially if winning any prize at the Contest, and will not in any way do any harm to the reputation of VACGA and its members.

4. I am in reasonably good health and can to the best of my knowledge participate fully and without limitation in any Contest activities. I agree to indemnify and hold harmless VACGA, and its members against all claims, damages, losses, expenses or liability arising from any injury that may occur to me during the practices and on the event date.

5. I will permit my name, photographs, pictures, endorsement rights to be used by the Vietnamese American Community of GA. I acknowledge that the title reign is good for one year only from the Contest date.

6. All photographs, video tapes, audio tapes, motion picture films, or other recordings or reproductions made of me, be they "still" or "live" as a contestant in the 2018 contest, or as a participant in the events leading up to the selection of "2018 Golden Voice Contest", either individually or as a member of the group, in connection with the 2018 contest, are, shall be, become and remain the property of the contest and the VACGA Festival Committee in perpetuity and same may be used and re-used by it, or anyone designated by it, or anyone designated by it in writing, for publicity, advertising or any other proper use.

7. This agreement shall solely and exclusively determine my rights, privileges, and responsibilities to the Contest and no oral or other written statement shall be binding. Should any provision of this agreement be void or unenforceable, such provision shall be deemed omitted and this Contract, with such provision omitted, shall remain in full force and effect.

Any controversy or claim arising out of or relating to this contract or the breach thereof, shall be settled by arbitration in Atlanta, GA in accordance with the Rules of the American Arbitration Association and judgment upon the award rendered by the Arbitrator(s) may be entered in any court having jurisdiction thereof; provided, however, that this paragraph shall not in any way affect the rights of the Contest to seek injunctive relief in the event of any breach or attempted breach of this agreement.

9. If winning any prize at the Contest, I must at least but not limited attend and help in two (2) main VAC GA activities and, or events as assigned for the time after this Contest until next year Contest. I will make myself available and dress all ribbons granted at the Contest if required.
